ORDER

The Chariman, S.C.V.V. and Trust Fund Committee, Mahalingpur owner of S.Nos. 66, 67, 68 and 69 of Mahalingpur has put in a application for grant of N.A. permission to convert an area of 4 acres 25 gunthas entire area of lands S.No. 66, 67, 68 and 69 of M Mahalingpur for N.A. viz construction of High School Building and play-ground. The site plan is duly approved by the President Mahalingpur Municipality. The Chairman is willing to pay the requisite N.A.A. and abide by any of the conditions that may be imposed by Govt.

The Tahasildar Mudhol after necessary enquiry has reported * that the proposed building as per approved plan(P-II) are situated at distance of more than 100' from the road and do not affect the provisions of the Ribbon Development Rules; that the permission applied for the accordingly recommend to grant the requisite N.A. Permission on payment of annual N.A. assessment of Rs. 346-87 subject to usual conditions.

In the circumstances, the Assistant Commissioner, Jankhandi Division, Jankhandi is pleased to grant permission to the applicant Chairman, S.C.P.V.V. Trust Fund, Mahalingpur to convert the lands S.Nos. 66, 67, 68 and 69 of Mahalingpur, for N.A. purpose i.e. construction of High School Building and play-ground as per approved plan(P-II) as shown below:-

The permission applied for is granted subject to the following conditions in addition to usual ones.

- i) permission for N.A. use is granted subject to the payment of N.A. assessment or conversion fine or both N.A. assessment and conversion fine leviable under the Rules in force on the date of order-granting N.A. permission and when decided but not later than 3 months from the date of intimation.
- ii) That the lands converted for N.A. purpose shall be used for the purpose of construction of High School building and play-ground.
- iii) that the building proposed shall be constructed according to the approved plan at P-II and no deviation shall be made without the permission for the competent authority

iv) That the utilisation of the area for the purpose shall be subject to the rules and regulations of the local Authority (Mahalingpur Municipality) within the Jurisdiction of which the lands are situated.

v) that the proposed structure in the lands should be constructed leaving a distance of 100' feet from the centre of the Mahalingpur to Mudhol Road.

vi) that breach of any of the conditions shall entail cancellation of the permission granted without payment of any compensation.

vii) that the grantee shall execute the Kapulayat within 3 months from the date of order.





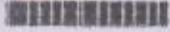
WHEREAS

1.
